**MAGISTRATES' COURTS ACT, 1944 (ACT NO. 32 OF 1944): WITHDRAWAL OF NOTICES CREATING DETACHED COURTS**

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(1) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) read with item 16(6) of Schedule 6 to the Constitution of the Republic of South Africa, 1996, hereby, with effect from 1 December 2014, abolish all the existing sub-districts and detached courts by withdrawing the government notices whereby those sub-districts were created in respect of the Gauteng and North West Provinces as indicated in Schedules 1 and 2, respectively.
