**SMALL CLAIMS COURTS ACT, 1984 (ACT NO. 61 OF 1984)****ESTABLISHMENT OF SMALL CLAIMS COURTS FOR THE AREAS OF NIGEL AND HEIDELBERG AND WITHDRAWAL OF GOVERNMENT NOTICE NO. 276 OF 24 FEBRUARY 1989**

I, Andries Carl Nel, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) (i) establish a Small Claims Court for the adjudication of claims for the area of Nigel, consisting of the district of Nigel;
- (ii) determine Nigel to be the seat of the said Court; and
- (iii) determine Nigel to be the place in that area for the holding of sessions of the said Court.
- (b) (i) establish a Small Claims Court for the adjudication of claims for the area of Heidelberg, consisting of the district of Heidelberg;
- (ii) determine Heidelberg to be the seat of the said Court; and
- (iii) determine Heidelberg to be the place in that area for the holding of sessions of the said Court.
- (c) withdraw Government Notice No. 276 of 24 February 1989.

Despite the withdrawal of Government Notice No. 276 of 24 February 1989, any claim emanating from the district of Heidelberg which has already been instituted in the Small Claims Court of Nigel prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Nigel as if this Government Notice has not been published.
