**PROMOTION OF EQUALITY AND PREVENTION
OF UNFAIR DISCRIMINATION ACT, 2000****DESIGNATION OF MAGISTRATES' COURTS AS EQUALITY COURTS;
DEFINITION OF THE AREA OF JURISDICTION OF EACH EQUALITY
COURT; AND APPOINTMENT OF PLACES WITHIN THE AREA OF
JURISDICTION OF EACH EQUALITY COURT FOR THE HOLDING OF
EQUALITY COURT SITTINGS**

I, Penuell Mpapa Maduna, Minister for Justice and Constitutional Development, under section 16(1) of the Promotion of Equality and Prevention of Unfair Discrimination Act, 2000 (Act No. 4 of 2000) and after consultation with the head of the administrative region as defined in section 1 of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby –

- (a) designate under column A of the Schedule the Magistrate's Court/s mentioned under each item in column A as equality court/s for the administrative region mentioned in that item in column B;
- (b) define the area of jurisdiction of each equality court mentioned in column A, to consist of the district/s, sub-district/s or other areas of jurisdiction created in terms of section 2 of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), as mentioned in that item in column C; and

- (c) appoint the places as mentioned in column D within the area of jurisdiction of each equality court mentioned in that item for the holding of equality court sittings.
