

ORDER

HAVING heard counsel for the Applicant and having read the papers filed of record the Tribunal makes an order in the following terms:

1. A rule *nisi* granted on 17 December 2020 is hereby confirmed.
2. The First Respondent is interdicted and restrained, pending the finalisation of the revival of the rule *nisi* or the retrospective extension of time, in respect of a rule *nisi* granted by the Honourable Mme Justice Modiba on 4 September 2020, which is set down for 5 February 2021, and which was declared to have lapsed by the Honourable Mme Justice Modiba 24 November 2020 (“*the revival application and/or condonation application*”) from making payments to the Third Respondent or any other person in respect of the pension benefits of the Second Respondent.
3. That, if the First Respondent has already released the money or the money would be released to the Third Respondent or any other party after the rule *nisi* granted on 17 December 2020, the Third Respondent or any other party is interdicted and restrained from releasing the money to the Second Respondent or any other person or dealing with the money in any other manner pending the finalisation of the revival application and/or condonation application.
4. Costs are reserved.
