**IT IS HEREBY ORDERED:**


1. the normal rules of service, filing and enrolment and condoning the Applicants' non-compliance with the time limits as to service, filing and enrolment as provided for in the Rules of the Special Tribunal (*'Tribunal'*) are hereby dispensed with;
2. non-compliance with the provisions of paragraph 2(a) of the order granted by the Tribunal on 10 July 2020 is hereby condoned;
3. as amended, an order is granted:
  - 3.1. extending the period of 30 days stipulated in paragraph 2(a) of the order with an additional period of 30 days calculated from 25 August 2020;

3.2. extending the period of 60 days in terms of paragraph 2(b) of the order with an additional 30 days from the date of publication of the proclamation by the President of the Republic; and

3.3. directing that the twenty days in paragraph 2(c) shall apply from the last day of the extended period in paragraph 3.2 above.




